Potpisivanjem ove politike preduzeće ATLAS d.o.o eksplisitno izjavljuje da je potpuno razumelo politiku udruživanja organizacije s FSC objavljenu na sajtu [www.fsc.org](http://www.fsc.org), kojom je određena FSC poziciju u pogledu neprihvatljivih aktivnosti organizacije i pojedinaca koji već jesu ili bi želeli da se povežu sa FSC-om, kao i mehanizam za razdruživanja.

Uzimajući u obzir gore navedeno, ATLAS d.o.o eksplisitno prihvata sada i u budućnosti, dok odnos sa FSC postoji, da neće biti direktno ili indirektno uključena u sledeće neprihvatljive aktivnosti:

- a) Ilegalna seča i ilegalna trgovina drveta ili šumskega proizvoda;
- b) Povreda tradicionalnih i ljudskih prava v šumarstvu;
- c) Uništavanje zaščitenih oblasti v šumarstvu;
- d) Značajna konverzija šuma v plantaže ili druge namene;
- e) Uvođenje genetski modifikovanih organizama v šumarstvu;
- f) Kršenje bilo kojeg od osnovnih ILO (Međunarodna Organizaciona Rada) konvencija, kako je definisano u ILO Deklaraciji o osnovnim principima i pravima tokom rada.

# **ATLAS doo**

## **SELF-DECLARATION**

regarding FSC-POL-01-004

### **(Policy for the Association of Organizations with FSC)**

ATLAS doo is associated with the Forest Stewardship Council™ A.C., Oaxaca, Mexico, or one of its subsidiaries or affiliates (hereinafter: FSC) by being either a member of or having a contractual relationship with FSC.

Hereby ATLAS doo explicitly states that it has read and understood the “Policy for the Association of Organizations with FSC” as published under [www.fsc.org](http://www.fsc.org). This policy stipulates FSC’s position with regards to unacceptable activities by organizations and individuals which already are or would like to be associated with FSC as well as the mechanism for disassociation.

In light of the above, ATLAS doo explicitly agrees currently and in the future, as long as the relationship with FSC exists, not to be directly or indirectly involved in the following unacceptable activities:

- a) Illegal logging or the trade in illegal wood or forest products;
- b) Violation of traditional and human rights in forestry operations;
- c) Destruction of high conservation values in forestry operations;
- d) Significant conversion of forests to plantations or non-forest use;
- e) Introduction of genetically modified organisms in forestry operations;
- f) Violation of any of the ILO Core Conventions, as defined in the ILO Declaration on Fundamental Principles and Rights at Work, 1998.
